Round Background:

As the Westphalia-Floraland conflict drags on, the balance of power has substantially shifted. Floraland has pushed Westphalia entirely out of the northeast, beating back Westphalian forces they describe as unyielding and unjust occupiers. In the west, the Floraland military has won a stunning series of victories, recapturing key objectives including Fort Gnarltree and the nearby city of Dijamant. Elsewhere, the Floraland Navy has reestablished its control of waters off the country's coast, pushing the Westphalians back around the edge of the continent to the southern Paonga Sea. Kado Peavey, the Floraland Prime Minister, has sought to continue the surge by declaring that victory against Westphalia is nearly at hand.

Despite these shifting fortunes, neighboring countries such as Stanusm, Ghorman, and Blamore have kept a cautious eye on the conflict but have been careful to remain out of the conflict. However, Blamore has suddenly found itself the focus of intense international interest and concern as four fighters crossed over Blamore's border with Floraland, apparently intent on surrendering to the first military authorities they encountered. The four individuals belong to a private company known as the Black Sun Consortium. With all eyes on Blamore's Prime Minister, her cabinet hurriedly works behind the scenes to help advise her imminent public response...

Four Black Sun Consortium Fighters Surrender to Blamore Authorities

Pressure is mounting on the Blamore Prime Minister to publicly address her countries plans for dealing with the controversial individuals.



The Black Sun Consortium has played an increasingly controversial role in the Westphalia-Floraland conflict.

SUNDARI, BLAMORE – Under the cover of driving icy rainstorm, four members of the notorious Black Sun Consortium abandoned their tank and weapons at the southern border of Floraland before secretly crossing into neighboring Blamore late yesterday. The group made their way to a Blamore Border Defense checkpoint where they immediately surrendered, claiming extensive mistreatment during their employ with the Black Sun Consortium (BSC).

Although Blamore authorities have not released the identity of the four, the Prime Minister's office acknowledged that they are employees of BSC, the Westphalian company at the center of some of the fiercest fighting in Floraland. An official from the Blamore Ministry of Defense, who spoke on the condition of anonymity, confirmed that the group was made up of two males and two females who comprised a BSC tank crew. While BSC has been involved in numerous armed conflicts across Mingleton, its participation in Floraland has been unparalleled. The company has sent a force of more than 10,000 to the conflict, a commitment of manpower and resources unprecedented in the company's history.

The Westphalian government has remained silent on the matter of its connection with BSC, but questions persist about the nature of their relationship. Controversy has followed BSC throughout the war, with its fighters repeatedly being accused of war crimes and other atrocities by the Floraland government. The Prime Minister's office noted that the four individuals have admitted to taking part in fighting within Floraland as part of BSC's Armored Security Conglomerate—a newly formed group with a chilling reputation for its brutality and cruelty towards civilians. The four individuals have denied involvement in any war crimes but have offered to provide evidence against other BSC members for violations of International Humanitarian Law. In the wake of their surrender, Floraland has declared them to be mercenaries who should be turned over to face prosecution for their involvement in the conflict. All eyes are now on the Blamore Prime Minister, who is expected to publicly address the issue soon.

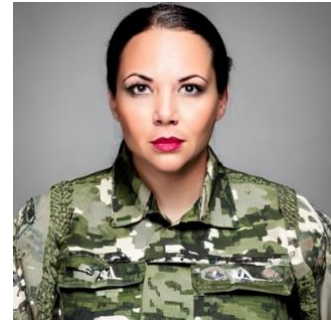

Investors across Mingleton are abuzz with KyberCoin, the newest and hottest cryptocurrency. This blockchain “coin” boasts the backing of BRX, the largest cryptocurrency exchange, which has fueled its rise.

CRYPTO RISING

“All in.” That is the refrain from investors across Mingleton when asked about the newest cryptocurrency, known as KyberCoin (KC). At the time of printing, KC was valued at \$39,650 Nortican Dollars (ND) per unit, the continent’s benchmark currency. It trades even higher elsewhere, such as in Westphalia where KC currently sits at an eye-popping \$57,890 Westphalian Dollars (WD) per unit. Despite being a relative newcomer on the block compared to other more established cryptocurrencies such as LitCoin and Detherium, having only been established a mere five years ago, it has seen a recent massive surge in popularity over the last 18 months.

KC’s origins are largely shrouded in secrecy and for the first few years of existence it was a non-factor in crypto markets, trading for mere pennies. What is clear is the moment in time KC’s fortunes changed. In early 2021, BRX, the massive cryptocurrency exchange led by Wunderkind Bankston Scott-Mifflin, elected to back the obscure KC in a move that caught crypto and other financial markets by surprise. With Mr. Scott-Mifflin hyping KC as the “future universal currency of the globe” and a flashy multimillion dollar ad campaign, KC and BRX have both skyrocketed in value, fueled by tens of thousands of small investors looking to finally wade into the cryptocurrency market.

While the crypto market has fully embraced KC, the rest of the globe is catching on slowly but surely. Governments and financial markets on the Mingleton continent are emblematic of this patchwork embrace as governments grapple with the rising force of the cryptocurrency market. Westphalia, as one of the first countries to fully embrace cryptocurrency, has led the charge in support of KC, making it fully legal tender on par with their standard currency, the WD. Other governments have adopted a more cautious or outright hostile approach to this novel type of currency, including KC. Currently, KC is only lawfully traded and accepted as legal currency in a few of Westphalia’s neighbors, Kalevala, and Ghorman. Some governmental entities and companies in those nations have even begun offering employees to be paid entirely in KC should they desire. On the other extreme Elsewhere, Nortico, Blamore, and Lockivo heavily regulate KC and other cryptocurrencies, severely limiting its trade and use in domestic transactions. On the other extreme, a contingent of nations including Floraland, Coastlandia, and Stanusm have outright banned use of cryptocurrencies for domestic transactions, while their governments refuse to accept such currencies in payment for international transactions. However, this difference in treatments across governments has not slowed KC’s rise. For now, KC is still a newcomer to the global cryptocurrency party, but it certainly seems as if the sky is the limit.

CRYPTO-BUST MARKETS ROCKED AS CRYPTO GIANT BRX COLLAPSES

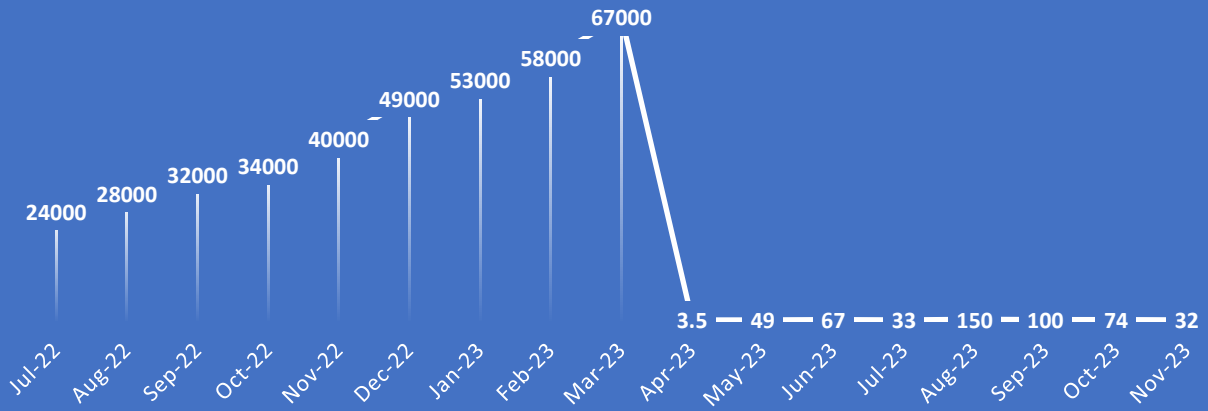
(CNN) – Financial markets across Mingleton are reeling after the sudden and stunning collapse of BRX, the leading global cryptocurrency exchange. Just days ago on April 10th, panic erupted amongst BRX customers as leaked company financials revealed the company’s troubled balance sheet, showing the company allegedly using customer funds as loans for risky stock market trades, while appearing to artificially prop up the value of KyberCoin, the cryptocurrency representing BRX’s largest single asset.

Panicked customers withdrew billions from the BRX exchange, causing BRX to declare an emergency halt all withdrawals. Meanwhile, KyberCoin investors across the globe began dumping the cryptocurrency in a similar panic, causing its value to plummet. Nortico, Blamore, and Lockivo, which already enforced some of the strictest cryptocurrency regulations on the continent, have issued emergency declarations banning the use of KyberCoin for transactions within their countries. Although KyberCoin remains unaffected by in Kalevala, Ghorman, and Westphalia, the once vaunted cryptocurrency initially plummeted in value, cratering to just below the value of a single dollar in those nations’ respective currencies.

These events mark a stunning collapse that does not yet appear to be over. BRX CEO Bankston Scott-Mifflin, who has remained conspicuously absent from public view, posted a video address on his personal Twitter account earlier this week, in which he loudly yelled “I declare bankruptcy.” Legal experts note that Mr. Scott-Mifflin’s video address does not, in fact, constitute a legal declaration of bankruptcy. While a formal BRX bankruptcy filing appears imminent, the fate of KyberCoin is less certain, as it has shown signs of rallying in value during the last 24 hours, rising back to approximately \$3.50 (WD) per unit.

Black Sun Consortium Members Convicted at Westphalian Court-Martial

The Westphalian government today announced that it had secured convictions against two Black Sun Consortium members at military court-martial proceedings, marking a surprising development in the typically murky relationship between the government and multinational provider of military services. In its brief press release on the matter, the government stated that the court-martial proceedings stem from an April 2023 incident in Floraland in which the defendants attempted to kill a Westphalian Army Colonel and his Executive Officer following a disastrous joint operation between Westphalian and Black Sun forces known as the Battle of Dijamant City in which the Westphalian Army allegedly utilized Black Sun fighters to absorb the brunt of enemy firepower during three failed assault waves.

Westphalia stated that the two had been tried and convicted of attempted murder of a superior and had been sentenced to life confinement at the Citadel Military Confinement Facility. Westphalia emphasized that the defendants were afforded all rights under the Westphalian Constitution pertaining to criminal trials. It is unknown precisely when the trial occurred. The Westphalian government provided no further specifics concerning the proceedings, which it described as a "specialized court-martial proceeding." Such a trial marks the first known time that a Westphalian military court has heard a case involving a civilian. Reached for comment, the Commander of Westphalian Forces, General Jeffrey Billingsworth, stated "we will not stand for premeditated attacks against our own, no matter who commits the act." Despite mounting criminal allegations against numerous other Black Sun members for their battlefield conduct in Floraland, there is no indication that Westphalia is planning to take similar action.

Although news of the trial was well received as a measure of accountability for the notorious Black Sun Consortium, questions still remain about their relationship with Westphalia.

Major General Merrik,

Good afternoon, Sir. Per your standing orders, we're continuing to monitor Black Sun Consortium (BSC) activities within the Westphalia-Floraland conflict. Our most recent intelligence summary is as follows:

1. Consistent with recent open-source reporting and intelligence, BSC continues to operate both in conjunction with Westphalian forces in certain areas and completely independent in others. We have seen no change in previously reported degrees of coordination between BSC and Westphalian forces.
2. BSC fighters continue to appear on the battlefield wearing traditional Westphalian Army uniforms, a practice that was first observed roughly two months into the conflict, with BSC fighters eschewing their original hodgepodge of olive drab uniforms in favor of Westphalian Army uniform tops and trousers. Despite this shift, BSC forces continue to exclusively wear a specialized helmet (pictured in the attachment) that is very distinct from the design and appearance of the usual Advanced Combat Helmet (ACH) that is standard issue to all Westphalian armed forces. BSC fighters also appear to uniformly wear a patch emblazoned with the BSC corporate logo (also pictured in the attachment), which is distinct from any known Westphalian military unit insignia.
3. The BSC's armored contingent (formed shortly before the conflict broke out) remains active. While they began the conflict using a mix of tanks, include the XG-7 "Redeemer" and FR-9 "Delta" models (aging variants that have largely been phased out of use by the Westphalian Army), they recently appear to be fielding the highly sophisticated X-1A Juggernaut, which boasts an impressive suite of specifications that put it on par or ahead of the best main battle tanks currently in service. A fact sheet of known and estimated information about this platform is attached, but it remains a closely guarded secret of the Westphalian military.
4. BSC fighters continue to fight using a variety of standard issue Westphalian military equipment, including the Westphalian Army KA-12 carbine.

WESTPHALIA OFFENSIVE CAMPAIGN ASSESSMENT, SUPPLEMENTAL REPORT, NOVEMBER 7, 2023

This special report supplements the standard WSI daily campaign assessment which addresses ongoing developments concerning the Black Sun Consortium forces operating within Floraland.

The Black Sun Consortium (BSC) has steadily increased the scope of its operations within Floraland during the first five months of the conflict. BSC has increased its number of fighting forces within Floraland since the conflict began in March 2023. BSC has increased from an initial Battalion-sized element (~1,000 individuals, mostly logistics and support personnel) to a Division-plus sized element of approximately 16,000 individuals.

BSC has similarly escalated and expanded the nature of its operations in the conflict. At the outset of the conflict, BSC appeared to primarily be engaged in limited operations including transporting supplies into and within Floraland and providing security services for both the Floraland-based assets of its parent company, Trion Energy Systems, but also for newly established Westphalian Forward Operating Bases within the country. Westphalia's invasion of Ibaar Province in the northeast marked a turning point in BSC's involvement, as its personnel were brought in to fight against the provincial armed resistance group known as "The Makara." As BSC increased its personnel, so too did it shift the nature of its operations. The expanded BSC force is now fully engaged in offensive combat operations across the entire Floraland battlespace, including through employment of its large-scale fleet of combat-capable drones and its newly formed "Armored Security Conglomerate," (ASC) which is comprised of tanks and other vehicles that typically comprise an armored unit within a military force.

BSC continues to conduct a wide range of operations in Floraland. BSC continues to engage in joint operations with Westphalian armed forces. In particular, its ASC is primarily engaged in combined arms operations, which features its tanks serving as the primary armored element, backed by Westphalian infantry and airpower. The precise level and flow of command and control in these operations remains murky. BSC employs its own "officer corps" of more senior or seasoned fighters who fill the role traditionally occupied by military commanders. BSC is actively engaged in numerous unilateral operations within Floraland, including ongoing assaults of a series of industrial complexes at the base of the northern Iridium Mountains, which are key processing facilities for valuable minerals mined from the mountains. These operations have not aligned with current Westphalian military priorities and are executed without any apparent support from or coordination with the Westphalian military. However, in several operations such as the major battle of Dijamant City in April, BSC forces appear to cede operational authority of their forces to Westphalian ground commanders. Elsewhere, BSC has been observed to reroute its forces to reinforce Westphalian units that are in danger during combat operations. The Westphalian government has remained silent on all matters related to BSC's operations and involvement in the conflict.
