RECENT ARMED CONFLICT BETWEEN JORGGE AND LAUDEST: A STRATEGIC INVASION AMIDST CONTINENTAL TENSIONS

In a sudden and unsettling turn of events, the neighboring nations of Jorgge and Laudest found themselves embroiled in a full-scale armed conflict yesterday. MSF condemns the misuse of its logo in conflict between Laudest and Jorgge

March 22, 2025

Capital of Laudest (MSF) – Doctors Without Borders/Médecins Sans Frontières (MSF) has learned of a deeply concerning incident that took place in the context of the armed conflict between Jorgge and Laudest and strongly denounces any misuse of its logo.

Private sources within the Jorggean Defense Ministry and independent journalism sources report that today, three men wearing the logo of MSF approached a Jorggean road checkpoint. They presented documents that seemed suspicious to the soldiers staffing the checkpoint, and upon being questioned, began to fire upon the checkpoint, injuring one soldier. These men were subdued without the use of lethal force and taken into detention. MSF understands that upon questioning, the men admitted to being intelligence operatives for Laudest.

MSF was immediately contacted by the Jorggean Defense Ministry to demand an explanation. MSF confirmed that there was no movement of our staff in the area planned for that day and that we always coordinate in advance with all relevant authorities to ensure predictability and the safety of all those involved. Accepting MSF's explanation, Jorgge called the incident "a perfidious act of our dishonest adversary".

A spokesperson for the Laudest Defense Ministry did not confirm the existence of the operation nor that the men, who remain in Jorggean detention, were members of the Laudest armed forces, but she did say, "Laudest intelligence services use a number of advanced tactics to gather a superior understanding of the operating environment." Laudest's military manual specifies that operatives not in uniform are not authorized to participate in operations whose intention is to kill or injure enemy combatants, but that they are allowed to use the means at their disposal to evade capture.

MSF has temporarily suspended its activities while it rebuilds trust with the parties. "The very lives of our staff depend on the protection and respect for our logo," said Claire al-Khatibi, MSF emergency coordinator, "and it is completely unacceptable to use our logo for military gain."

MSF is an international, independent, medical humanitarian organization that delivers emergency aid to people affected by armed conflict, epidemics, natural disasters and exclusion from medical care, irrespective of race, religion, creed or political conviction. These values of neutral humanitarian intervention are what are represented in MSF's identification and trademarks.

MSF calls on all authorities to urgently address this issue and refrain from using the identification, symbols, or trademarks of MSF.

5. SUMMARY OF INCIDENT:

An unmarked white vehicle approached the checkpoint with three men inside. The men claimed to be with Médecins Sans Frontières/Doctors Without Borders (MSF). This was surprising to the personnel of the checkpoint, as humanitarian movements are typically coordinated centrally and informed to all relevant checkpoints before the fact. Due to this unexpected activity, Private First Class Kai Jennings asked the men to exit the vehicle while conducting further verification. Upon exiting, it was clear that the men were wearing shirts printed with the logo of MSF. PFC Jennings requested the men's identification documents. They handed over the documents. PFC Jennings noticed that the serial numbers on the men's passports were sequential (41278150, 41278151, 41278152), a highly unlikely coincidence. PFC Jennings reported the suspicious documents to Corporal Morgan Williams, responsible for leadership of the checkpoint.

At the same time, Private Riley Harbottle walked around the perimeter of the vehicle to conduct an external search and did not see any medical or humanitarian supplies in the vehicle visible from the exterior.

CPL Williams asked the men to verify various pieces of biographical information on their passports and to explain their humanitarian mission. After approximately 90 seconds of this line of questioning, the man furthest from CPL Williams pulled out a concealed pistol and began to fire. It is not clear whether the shooter had a target in

mind or shot to cause a distraction, but the shot caught PVT Harbottle in the left shoulder. The other two men did not draw firearms at this time.

CPL Williams tackled the shooter to the ground. PFC Jennings used an electric stun weapon to subdue the second man then brought the third man to the ground using physical force. PVT Harbottle drew a service weapon and aimed at the men but did not fire. CPL Williams and PFC Jennings placed the three men in secure restraints.

Thorough inspection revealed that the other two men were also armed. A search of the vehicle produced several pieces of radio frequency surveillance equipment, audio and visual recording devices, night vision goggles, and tools for lockbreaking.

CPL Williams questioned the men again about their identity. They remained silent.

PVT Harbottle identified the pistol as the same model as those issued to members of the Laudest armed forces. CPL Williams radioed for a transport to take the men to

Detention Facility for interrogation and detention.

The Surrender Interrupted: A War Correspondent's View From the Frontlines

The hour was late, and the sky was filled with storms. We were in the heart of it — a group of tired soldiers from Laudest on defensive patrol. But today, something different hung in the air. We encountered a Jorggean unit and a brief battle broke out. Luck was on our side and the Jorggeans were outflanked, they quickly surrendered once their situation became clear to them.

I was embedded with the Laudest 3rd Infantry Division — a seasoned group of men and women who had seen more than their fair share of combat, but now, their mission was different: to accept the surrender of a Jorggean platoon that had just raised the white flag. It had started with a slow, cautious approach — the Jorggean soldiers stepping out from their defensive positions, hands raised high, weapons slung loosely over their shoulders. They were disheveled, exhausted, their faces etched with the weariness of war. The officers from both sides met in the middle of the destroyed field, while the rest of the soldiers stood at attention, watching silently, awaiting the outcome.

I moved closer, keeping my distance, my camera rolling. There was something haunting about this moment — something deeply human. This wasn't just a military operation; it was a scene that marked the end of a brief chapter of violence, a temporary respite of peace. And then, without warning, the world exploded into chaos.

A series of distant, thunderous explosions rumbled from the hills. The ground trembled as artillery shells rained down, striking the earth in violent bursts. The sound of incoming fire rang through the air as a second Jorggean unit charged in from the west to aid their comrades. The surrender was over. The battlefield was alive again, but now it was filled with a new kind of madness.

Before anyone could react, the Jorggean unit that had just laid down its arms snapped into action. Soldiers scrambled to retrieve their rifles from the ground, their faces morphing from defeated exhaustion to grim determination. The men who had just moments before embraced surrender now turned on us, raising their weapons with deadly intent.

I dove behind a nearby pile of rubble, my heart pounding in my chest as I tried to steady the camera. Gunfire erupted from every direction. The suddenness of the attack left us scrambling, the Laudest soldiers fighting to regain the initiative while the Jorggean forces reformed into battle lines, their earlier surrender forgotten in an instant. It was as if they had never even considered capitulation, as if it had all been a ploy to draw us into a false sense of security. The Jorggean commander, the same man who had stood just moments ago in the midst of what we thought was an official ceasefire, now stood shouting orders, his hands raised as he directed his troops in a fierce counterattack.

Our side was scattered. The Laudest forces, accustomed to the brutality of war, quickly regained their composure, but the element of surprise had been lost. Soldiers dove into trenches, returning fire as the air around us buzzed with the crack of bullets and the thud of mortar rounds.

It wasn't until hours later, after the smoke had cleared and the echoes of gunfire had faded, that I found myself standing among the remnants of what was once an orderly battlefield. The bodies of Jorggean and Laudestan soldiers lay scattered across the landscape, some still clutching their rifles, others fallen where they had tried to retreat. It was a grotesque scene, one that I had witnessed countless times in my career, but it never grew any easier.

The surrender, which had seemed like a glimmer of hope, had been shattered — not by a single force, but by the unpredictability of war itself. A fleeting moment of peace turned into the sharp sting of betrayal and death, and now we were left with nothing but the silence that followed. As I walked among the fallen, I couldn't help but wonder if this was truly the end of the war. Or if, like so many times before, it was simply the beginning of another chapter in an endless cycle of violence. And somewhere in the distance, far beyond the reach of both Laudest and Jorgge, the war still raged on.

Jorggean Military Report: Post-battle report by Lt. Luiza Savard of Foxtrot Platoon

Location: Aranmount Industrial Mining Complex in the northwestern border regions of Laudest.

Time: 10:37pm, March 22, 2025

Environmental Conditions: Heavy thunderstorms leading to reduced

visibility and hearing range.

Terrain: Industrial mining area, large number of big buildings, dirt mounds, large broken industrial machinery obstructing sight lines. The significant amount of metal in area wreaks havoc on communications networks.

Our forces in the area:

Bravo Platoon, led by Lt. Catherine Fernandes

Foxtrot Platoon, led by myself, Lt. Luiza Savard

 -30 soldiers in each unit, each unit operates on a different radio frequency

Facts:

 Both Brave and Foxtrot were on patrol in the border regions in Laudest, just beyond the fortified lines held by the Jorggean army.

Suddenly, at -10:24, shot's rang out across the complex, likely from the area being swept by Bravo platoon. We approached cautiously, unsure how many hostile combatants were in the area.

 Over the radio, Lt. Fernandes came onto our frequency and attempted to communicate something as the amount of gunshots began to rapidly subside. I was only able to make out the following:

"We are surrounded by ZZZZ about to ZZZZZZ Laudest ZZZZZ by

the car park. Be advised, over.

 My forces and I slowly advanced on the car park only to find Lt. Fernandes and her surviving troops in the middle of surrendering to Laudest forces.

· We positioned ourselves carefully and launched an attack with guns and an artillery strike scattering Laudest's positions and

saving Bravo Platoon.

Brave Platoon immediately dove for their weapons and began to

fight alongside us.
The chaos of battle led to some further casualties on either side and both Bravo and Foxtrot retreated back to our defensive lines as the Laudest forces seemingly did the same.



Deafening Weapons – A Human Alternative or Unnecessary Suffering?

March 21, 2025

As militaries continue to develop their weapons capabilities, innovations in the field claim to offer more effective, more efficient, and more humane alternatives. The Jorgge-developed and -manufactured Long-range Otological Blast Equipment (LOBE) is a new weapons system that is not merely in testing. Human Rights Watch has now verified reports that the LOBE has been deployed on the battlefield in the conflict between Jorgge and Laudest.

The LOBE purports to send a focused one-time "impulse" sound in the subsonic frequency that cannot be processed by the ear as sound but has the strength to cause temporary deafness in the target. The LOBE has been measured at volumes of up to 160 dB, a volume sufficient to cause immediate harm to the sense of hearing and physical pain to the listener.

Dockheed Clartin Inc., the developer of the LOBE, claims that the LOBE is a safe weapon to use on the battlefield, using cutting-edge technology to focus a wave of sound toward a specific target instead of dispersing it in a wide area. In its press release announcing the acquisition of the weapons system, Jorgge stated, "The use of the LOBE will allow us to temporarily incapacitate the enemy in a humane and highly cost-efficient way. We have undergone rigorous testing with the weapon and are confident of its usefulness to our armed forces."

The Jorggean Audiologists Association has decried the use of the weapon, claiming that the sound it emits is sufficient to cause permanent complete deafness in 10% of cases and permanent partial hearing loss in an additional 30% of cases.

After approximately 90 seconds of this line of questioning, the man furthest from CPL Williams pulled out a concealed pistol and began to fire. It is not clear whether the shooter had a target in

mind or shot to cause a distraction, but the shot caught PVT Harbottle in the left shoulder. The other two men did not draw firearms at this time.

CPL Williams tackled the shooter to the ground. PFC Jennings used an electric stun weapon to subdue the second man then brought the third man to the ground using physical force. PVT Harbottle drew a service weapon and aimed at the men but did not fire. CPL Williams and PFC Jennings placed the three men in secure restraints.

Thorough inspection revealed that the other two men were also armed. A search of the vehicle produced several pieces of radio frequency surveillance equipment, audio and visual recording devices, night vision goggles, and tools for lockbreaking.

CPL Williams questioned the men again about their identity. They remained silent.

PVT Harbottle identified the pistol as the same model as those issued to members of the Laudest armed forces. CPL Williams radioed for a transport to take the men to

Detention Facility for interrogation and detention.

The Surrender Interrupted: A War Correspondent's View From the Frontlines

The hour was late, and the sky was filled with storms. We were in the heart of it — a group of tired soldiers from Laudest on defensive patrol. But today, something different hung in the air. We encountered a Jorggean unit and a brief battle broke out. Luck was on our side and the Jorggeans were outflanked, they quickly surrendered once their situation became clear to them.

I was embedded with the Laudest 3rd Infantry Division — a seasoned group of men and women who had seen more than their fair share of combat, but now, their mission was different: to accept the surrender of a Jorggean platoon that had just raised the white flag. It had started with a slow, cautious approach — the Jorggean soldiers stepping out from their defensive positions, hands raised high, weapons slung loosely over their shoulders. They were disheveled, exhausted, their faces etched with the weariness of war. The officers from both sides met in the middle of the destroyed field, while the rest of the soldiers stood at attention, watching silently, awaiting the outcome.

I moved closer, keeping my distance, my camera rolling. There was something haunting about this moment — something deeply human. This wasn't just a military operation; it was a scene that marked the end of a brief chapter of violence, a temporary respite of peace. And then, without warning, the world exploded into chaos.

A series of distant, thunderous explosions rumbled from the hills. The ground trembled as artillery shells rained down, striking the earth in violent bursts. The sound of incoming fire rang through the air as a second Jorggean unit charged in from the west to aid their comrades. The surrender was over. The battlefield was alive again, but now it was filled with a new kind of madness.

Before anyone could react, the Jorggean unit that had just laid down its arms snapped into action. Soldiers scrambled to retrieve their rifles from the ground, their faces morphing from defeated exhaustion to grim determination. The men who had just moments before embraced surrender now turned on us, raising their weapons with deadly intent.

I dove behind a nearby pile of rubble, my heart pounding in my chest as I tried to steady the camera. Gunfire erupted from every direction. The suddenness of the attack left us scrambling, the Laudest soldiers fighting to regain the initiative while the Jorggean forces reformed into battle lines, their earlier surrender forgotten in an instant. It was as if they had never even considered capitulation, as if it had all been a ploy to draw us into a false sense of security. The Jorggean commander, the same man who had stood just moments ago in the midst of what we thought was an official ceasefire, now stood shouting orders, his hands raised as he directed his troops in a fierce counterattack.

Our side was scattered. The Laudest forces, accustomed to the brutality of war, quickly regained their composure, but the element of surprise had been lost. Soldiers dove into trenches, returning fire as the air around us buzzed with the crack of bullets and the thud of mortar rounds.

It wasn't until hours later, after the smoke had cleared and the echoes of gunfire had faded, that I found myself standing among the remnants of what was once an orderly battlefield. The bodies of Jorggean and Laudestan soldiers lay scattered across the landscape, some still clutching their rifles, others fallen where they had tried to retreat. It was a grotesque scene, one that I had witnessed countless times in my career, but it never grew any easier.

The surrender, which had seemed like a glimmer of hope, had been shattered — not by a single force, but by the unpredictability of war itself. A fleeting moment of peace turned into the sharp sting of betrayal and death, and now we were left with nothing but the silence that followed. As I walked among the fallen, I couldn't help but wonder if this was truly the end of the war. Or if, like so many times before, it was simply the beginning of another chapter in an endless cycle of violence. And somewhere in the distance, far beyond the reach of both Laudest and Jorgge, the war still raged on.

Jorggean Military Report: Post-battle report by Lt. Luiza Savard of Foxtrot Platoon

Location: Aranmount Industrial Mining Complex in the northwestern border regions of Laudest.

Time: 10:37pm, March 22, 2025

Environmental Conditions: Heavy thunderstorms leading to reduced

visibility and hearing range.

Terrain: Industrial mining area, large number of big buildings, dirt mounds, large broken industrial machinery obstructing sight lines. The significant amount of metal in area wreaks havoc on communications networks.

Our forces in the area:

Bravo Platoon, led by Lt. Catherine Fernandes

Foxtrot Platoon, led by myself, Lt. Luiza Savard

 -30 soldiers in each unit, each unit operates on a different radio frequency

Facts:

 Both Brave and Foxtrot were on patrol in the border regions in Laudest, just beyond the fortified lines held by the Jorggean army.

Suddenly, at -10:24, shot's rang out across the complex, likely from the area being swept by Bravo platoon. We approached cautiously, unsure how many hostile combatants were in the area.

 Over the radio, Lt. Fernandes came onto our frequency and attempted to communicate something as the amount of gunshots began to rapidly subside. I was only able to make out the following:

"We are surrounded by ZZZZ about to ZZZZZZ Laudest ZZZZZ by

the car park. Be advised, over.

 My forces and I slowly advanced on the car park only to find Lt. Fernandes and her surviving troops in the middle of surrendering to Laudest forces.

· We positioned ourselves carefully and launched an attack with guns and an artillery strike scattering Laudest's positions and

saving Bravo Platoon.

Brave Platoon immediately dove for their weapons and began to

fight alongside us.
The chaos of battle led to some further casualties on either side and both Bravo and Foxtrot retreated back to our defensive lines as the Laudest forces seemingly did the same.



Deafening Weapons – A Human Alternative or Unnecessary Suffering?

March 21, 2025

As militaries continue to develop their weapons capabilities, innovations in the field claim to offer more effective, more efficient, and more humane alternatives. The Jorgge-developed and -manufactured Long-range Otological Blast Equipment (LOBE) is a new weapons system that is not merely in testing. Human Rights Watch has now verified reports that the LOBE has been deployed on the battlefield in the conflict between Jorgge and Laudest.

The LOBE purports to send a focused one-time "impulse" sound in the subsonic frequency that cannot be processed by the ear as sound but has the strength to cause temporary deafness in the target. The LOBE has been measured at volumes of up to 160 dB, a volume sufficient to cause immediate harm to the sense of hearing and physical pain to the listener.

Dockheed Clartin Inc., the developer of the LOBE, claims that the LOBE is a safe weapon to use on the battlefield, using cutting-edge technology to focus a wave of sound toward a specific target instead of dispersing it in a wide area. In its press release announcing the acquisition of the weapons system, Jorgge stated, "The use of the LOBE will allow us to temporarily incapacitate the enemy in a humane and highly cost-efficient way. We have undergone rigorous testing with the weapon and are confident of its usefulness to our armed forces."

The Jorggean Audiologists Association has decried the use of the weapon, claiming that the sound it emits is sufficient to cause permanent complete deafness in 10% of cases and permanent partial hearing loss in an additional 30% of cases.

You guys, it's really crazy out here, and the world needs to know the truth. As you know, I've been treating our soldiers on the battlefield, and I've never seen anything like this. For the last week, I've been getting all sorts of injuries that look like the severe ear damage from a massive explosive blast, but they don't have a scratch on them. It must be this new weapon Jorgge is bragging about.

Apparently they said it's "safe", but they are lying to you, and they're lying to everybody. This is absolutely not just temporary damage. I have guys here who can't hear a single thing more than a week after getting hit, and a lot of them will probably never fully recover. Of the 50 I've treated, at least 15 are completely deaf. There's no way we can send them back out to fight.

Where is the outrage? Will the world really be silent while Jorgge uses this cruel weapon? Are they really going to get away with this?
